Texas 2000 Air Quality Study Workshop

A major Science Team meeting for the Texas 2000 Air Quality Study (TexAQS 2000) is scheduled for three and a half days, from Tuesday August 7th through noon Friday, August 10th, 2001. The meeting will be held at the University of Texas - Pickle Research Campus in Austin, Texas. This will be the first large public presentation of early scientific findings from the study. Most of the results presented this August will come from individual investigators or from working groups. Session 7. Modeling of TexAQS 2000
Session 8. Plans for integrated analysis

The goal of the session is to focus on science and what has been learned from the study as opposed to trying to have everyone present his / her individual results. Ample time for discussion will be scheduled at the end of each session, or in some cases at the end of a group of presentations. There will be space for poster presentations to illustrate measurement technologies and detailed measurement results.
